



## **Position Description**

### **State Policy Affairs Representative (SPAR) of the National Pest Management Association**

State Policy Affairs Representatives (SPARs and Vice-SPARs) are members who work full-time in the industry, while also working voluntarily to protect and advocate for their industry. These individuals are extremely passionate and dedicated to protecting public health and advocating for thoughtful science-based decision-making. SPARs represent their state's industry and work with their state association board or legislative committee and NPMA's Public Policy Team. Their state association board nominates SPAR and Vice-SPARs for two-year terms and there are no limits on the number of terms.

### **SPAR Duties**

- Serve as the liaison between NPMA and their state association's work in state legislative and regulatory matters.
- Keep NPMA Public Policy team members on current needs and actions taken on any legislation in the state.
- Attend Monthly SPAR calls on the last Tuesday of the month.
- Do their best to attend Legislative Day in March and the Association Impact Meeting (AIM), (formally known as SPAR Bootcamp).
- Develop and maintain relationships with state legislators and regulators and establish the importance and presence of the pest control industry among their state leaders.
- Be available to attend and testify at legislative hearings.
- Meet with legislators, staff, and regulators on current issues

- SPARs are members of both their state association and NPMA.
- Have a passion for advocating for the pest management industry, protecting public health, and science-based decision-making.
