Joe discussed the Environmental Protection Agencies (EPA) review of the current Certification and Training (C&T) federal rule. EPA has been working on this issue for some time. MPMA and other interested parties have submitted comments. At this point, proposed EPA changes in the C&T Rule will have minimal impact on our industry in Minnesota.

Joe then discussed licensed structural pest control applicators attendance at the 2017 Structural Pest Control Conference. The Minnesota Department of Agriculture (MDA) mandates that attendees attend all required topics. MDA will be monitoring attendance, and has the authority to deny a license to individuals that fail to attend the required topics.

Joe discussed proposed legislative language for pesticide use in multi unit housing. The proposed language is currently in the Commissioner's Office for review. At this time Joe is not aware of the status of this proposal.

## Mike Fresvik, Minnesota Pest Management Association:

MPMA has two opening on its Board of Directors. MPMA President Rob Greer and past President Todd Leyse have selected two individuals for nomination and board member approval.
